# State of Frigia

## Decree #1 (The Constitution)

#### The State

- 1. Henceforth, the State of Frigia shall be an independent nation.
- 2. The State of Frigia shall be a unitary, absolute monarchy.
- 3. The State of Frigia, at the time of this decree's writing, consists of the Ross Island upon the continent of Antarctica.
- 4. The official demonym of the state shall be "Frigian".
- 5. The official arms of the state shall be a light cyan shield, with a white map of Ross Island atop it, and the inscription "State of Frigia" on the top half of the shield, with the word "Frigia" being in bold font.
- 6. The official flag of the state shall be split in 2 horizontally, with the bottom half being light cyan, and the top white, with the arms of the state atop the white half.

#### The Frigior

- 1. The state shall be led by the Frigior, the sovereign of the state who shall hold all powers legislative, executive, and judicial.
- 2. The Frigior may delegate his powers as he desires.
- 3. Upon the death or abdication of the Frigior, a new Frigior shall be selected through Absolute Primogeniture, unless the Frigior selects an heir to take their place instead.
- 4. If the Frigior declares himself incapable of executing his duties, he may appoint a Regent to execute his duties on his behalf temporarily.
- 5. The Frigior shall be known as "Frigior (Given name) (Regnal number) of Frigia", and shall hold the style of "His/Her Majesty".
- 6. In the event that there is a Regent in place, the Regent shall be known as "Regent (Given name) of Frigia", and shall hold the style of "His/Her Majesty".
- 7. The heir apparent shall be known as "Crown Prince (Given name) of Frigia" if male, and "Crown Princess (Given name) of Frigia" if female, and shall hold the style of "His/Her Highness".
- 8. The siblings and children of the heir apparent shall be known as "Prince (Given name) of Frigia" if male, and "Princess (Given name) of Frigia" if female, and shall hold the style of "His/Her Highness".

#### **Administrative Divisions**

- 1. The state shall be split into Municipalities, each led by a Mayor.
- 2. The Mayor of each Municipality shall have legislative and executive powers within the Municipality they lead.
- 3. The Mayor may pass legislation within their Municipality, but if any of their legislation contradicts statutes enacted by the Frigior, it will be automatically repealed.
- 4. The Frigior may repeal legislation passed within the Municipalities.

- 5. The Mayor of each Municipality must have citizenship within that Municipality, unless, for any reason, a Mayor from that Municipality can not be selected, in which case, the Frigior may be appointed Mayor.
- 6. All Mayors shall hold the title of "Mayor of (Municipality name)", and the style of "The Honorable".

#### **Human Rights**

- 1. All people are equal, regardless of race, religion, sex, or sexuality.
- 2. All people have the right to receive healthcare and education.
- 3. All people have the right to think, speak, and express their opinions freely.
- 4. All people have the right to privacy.
- 5. No person may be prosecuted by the government without good, valid reason.

### Closing

- 1. This decree may not be repealed, amended, or suspended without a good, valid reason.
- 2. This decree shall go into effect on September 30<sup>th</sup>, 2024, at 1:15 PM, Eastern Daylight Time.
